

ANNUAL REPORT 2015

The Philippine Institute of Traditional and Alternative Health Care (PITAHC) continued to carry out its mandate as a research Institute for the last three years. Research projects were prioritized based on the Philippine Research and Development Framework on Traditional and Complementary Medicine (T&CM) approved by its Board of Trustees in 2014. This served as guidepost in the conduct of research projects during the year, specifically in the conduct of researches on conservation and protection of natural and cultural heritage of Philippine Traditional Medicine; research and development on safety, efficacy/benefit, and quality of Philippine medicinal plants and other natural products; clinical research on safety and efficacy/benefit of T&CM modalities; standards, policy and operations research; and knowledge management.

To ensure the quality, safety, and efficacy of T&CM, there must be appropriate standards for practice, education, and training of providers. Implementation of professional standards, when supported through regulation, enhances the learning base of practitioners, evokes confidence from patients and consumers in the health providers, enhances the stature of practitioners and ultimately leads to improved health care. This program involves development of competency standards and code of ethics for the practice of specific T&CM modalities such as: hilot, acupuncture, chiropractic, homeopathy, naturopathy, tuina, osteopathy, and other WHO recognized T&CM modalities. Relative to this, PITAHC has developed the said standards and code of ethics for the practice of the aforementioned modalities. Likewise, the standards on the accreditation of T&CM clinics, facilities, training centers, and associations were developed.

PITAHC intensified its promotion and advocacy services on the use of safe, effective, cost effective, scientifically validated, and culturally acceptable herbal products and T&CM modalities. These were done through quad media such as: social media, newsletters, television, radio advertisements, and public appearances. To further broaden its campaign, PITAHC established linkages and collaboration with the different local government units (LGUs), government agencies, non-government organizations, civil society groups, and stakeholders nationwide.

HIGHLIGHTS OF ACCOMPLISHMENTS

Research and Development

In partnership with the different research institutions such as University of the Philippines Manila-National Institutes of Health, National Integrated Research Program on Medicinal Plants, University of the Philippines Los Baños, Ateneo de Manila University, Health Futures Foundation Inc., Bicol University, University of Rizal System, Nueva Vizcaya State University, and Isabela State University a total of nine (9) research projects were completed out of the ten (10) that was targeted for the year (90% accomplished). From out of six (6) selected research projects that were completed for the last three years with at least 50% to be published as target, a total of four (4) (or 67%) was published at the PITAHC website and made available to the general public. Out of three (3) research projects that were targeted to be completed within

the proposed timeframe three (3) selected research projects were completed (100 % accomplished).

Standards and Accreditation

For this year, activities were geared towards the establishment of a system for the qualification, certification, and accreditation of T&CM practitioners, training centers, clinics, and associations.

Two (2) public hearings were conducted for the finalization of the Guidelines for the Certification and Accreditation of Hilot and Guidelines for the National Certification and Accreditation of Osteopathy. A total of eighty eight (88) T&CM practitioners were certified

consisting of seventy six (76) acupuncturists, five (5) naturopaths, three (3) chiropractors and four (4) homeopaths/homotoxicologists. Likewise, a total of six (6) training centers (3 for acupuncture, 2 for naturopathy and 1 for homeopathy/homotoxicology), four (4) clinics (3 for acupuncture and 1 for naturopathy), and three (3) traditional and alternative health care associations (2 for acupuncture and 1 for homeopathy/homotoxicology) were accredited. Out of the one hundred twenty seven (127) applications for certification and accreditation that was targeted, one hundred seventy (170) or 134 % was accomplished.

To foster cohesiveness among T&CM practitioners, several fora were organized such as the General Assembly conducted among certified chiropractors, Federation of Naturopathy Practitioners of the Philippines, hilot, and homeopathy/homotoxicology practitioners.

In order to address the problem on the proliferation of unregistered T&CM practitioners in Metro Manila, three (3) batches of LGU orientation on certification of practitioners and accreditation of clinics were conducted and participated by the city health officers (CHOs), and business permit licensing officers (BPLOs) from Pasig, Marikina, Quezon City, Tausig, Mandaluyong, Makati, Manila, San Juan, Caloocan City, Malabon, Navotas, Valenzuela, Muntinlupa, Paranaque, Las Piñas, and Pasay City.

As part of the responsive system for the reporting, monitoring, and responding to complaints related to T&CM practices, PITAHC developed monitoring tools and monitored six (6) accredited acupuncture clinics, four (4) chiropractic clinics, and two (2) homotoxicology clinics.

Social Advocacy and Training

For this year, PITAHC conducted two (2) Basic Acupuncture Training in Baguio City and Bicol University with a total of sixty four (64) participants (out of a target of 50). A total of eighty one (81) advocacy activities was carried out (out of a target of 64) through lectures/seminars/workshops on community-based herbal medicine preparation and acupressure, TV and radio interviews, public appearances, and participation in local and international exhibits/trade fairs and conventions. This represented a total of 145 which was 127% of the targeted 114.

A reference book (PITAHC Patnubay sa Paggamit ng Halamang Gamot Para sa Pamayanang Pilipino) had been developed. The reference book contains practical guidelines on the safe and beneficial use of medicinal plants used for common ailments in the community.

Noteworthy to mention is the success of the 7th TAHC Convention and Exhibit at Diamond Hotel, Manila last November 27-28, 2015. There were three hundred twenty (320) participants who attended and were impressed with the vast information on T&CM current researches, on trends and perspectives, and on strategies in integrating T&CM into the national health care delivery system.

Herbal Processing Plants

Tacloban Herbal Processing Plant (THPP) established a medicinal plant garden with an area of one hundred sixty square meters (160 sq.m.) dedicated to the collection, cultivation, preservation, promotion, and display of thirty (30) plants with known rich history of medicinal use in the region, labeled with concise information on their botanical, common and local names, efficacy and safety, beneficial and healing properties. Located in Bagacay, Tacloban City,

this herbal garden is a showcase wherein students and the public are provided with useful information on the different medicinal plants.

THPP also conducted the standard pharmaceutical formulation (Trial 1 Formulation) of *ulasimang bato* tablet 500 mg. Based on the different tests results, this anti-hyperuricemic drug proves to be a very promising herbal medicine and it is hoped that this will soon be marketed upon compliance with Food and Drug Administration (FDA) requirements for product registration.

THPP also served as venue for manufacturing internship of pharmacy students of St. Scholastica's College.

Cagayan Valley Herbal Processing Plant (CVHPP) completed the product development of *akapulko* ointment as anti-fungal agent. Likewise, CVHPP continuously conducted bio-assay and micro-assay testing of herbal products from other HPPs. The HPP served as a venue for manufacturing internship of pharmacy students from St. Paul University of the Philippines, Medical Colleges of Northern Philippines, International School of Asia and the Pacific, Lorma Colleges, and Saint Louis University Baguio. A total of eighty seven (87) students completed the two hundred (200) hours internship program.

Davao Herbal Processing Plant (DHPP) carried out product formulation of researches of post graduate interns from the different universities in Mindanao. DHPP is currently the main source of experimental animals being used by students and researchers in the region. It also served as a venue for manufacturing internship of pharmacy students from the University of San Carlos, University of Immaculate Concepcion, Notre Dame of General Santos City, University of Southern Mindanao, General Santos Doctors School, and San Pedro College. A total of seventy (70) students completed the two hundred (200) hours internship program. Technical assistance in the thesis development of students was also provided by the technical staff of the HPP.

Cotabato Herbal Processing Plant (CHPP) produces eight variants of herbal soap namely, *akapulko*, *bayabas*, *kamias*, *papaya*, *labanos*, *calamansi*, *cucumber* and *carrot*. *Bayabas* and *akapulko* soap are continuously procured by the DOH-retained hospitals as part of their Buntis and OB kits given to their patients. A total of 245,000 pieces of herbal soap were produced against the target of 200,000 pieces (123 % accomplished). Likewise, CHPP served as venue for manufacturing internship of pharmacy students from the University of Southern Mindanao. A total of twenty six (26) students completed the eighty (80) hours internship program.

For 2015, THPP, CVHPP and DHPP produced a total of thirty five million ninety six thousand three hundred eighty seven (35,096,387) tablets. The herbal medicines that were produced include *lagundi*, *sambong*, and *tsaang gubat* tablets.

Marketing and Sales

For this year, PITAHC supplied the requirements of government clients specifically the Department of Health and its retained hospitals. A net sales of P73.879 million was achieved against its target of P65.256 million (113% accomplished). Income generated from sales is used to augment the financial requirements needed to sustain the operation of the Institute.

Financial Report

Results of Operations

For Calendar Year 2015, PITAHC's HPPs focused their activities from production of herbal medicines and other herbal products into research and development, as mandated by the Governance Commission for Government Owned and Controlled Corporations (GCG) in its directive last September 2012.

Sales revenue (net of sales discounts) for CY 2015 amounted to P73.879 million lower than that of last year's by P18.383 million or by 20%, which is mainly attributed to the adjustment in the target sales from P92.262 million in CY 2014 to P65.256 in CY 2015, a reduction of P27.006 million. However, actual sales of P73.879 million was 13 % above the CY 2015 target.

Cost of sales registered at P30.723 million or 42 % of Net Sales, resulting into Gross Profit from Sales of P43.156 million.

Total Expenses amounted to P80.387 million consisting of Personal Services of P48.862 million, Maintenance and Other Operating Expenses of P31.515 million and Financial Expenses of P.010 million.

Loss therefore from Operations amounted to P37.231 million. However, after deducting other income of P6.694 million, net loss is registered at P30.537 million. Considering the P50 million

subsidy from the National Government and income tax of P0.562 million, net income is registered at P18.901 million.

Financial Position

As of December 31, 2015, the Institute generated total assets of P397.395 million consisting mainly of Cash of P175.209 million, Property, Plant and Equipment of P111.667 million, Receivables of P33.355 million, and Inventories of P 24.104 million.

Total liabilities amounted to P26.488 million, consisting mainly of Payables to contractors/suppliers.

Total equity as of December 31, 2015 amounted to P370.907 million consisting mainly of Government Equity of P73.238 million, and Retained Earnings of P297.669 million.
