As a contribution for the pursuit of Universal Health Care among Filipinos, PITAHC partnered with various DOH-retained hospitals for the establishment of TAHC centers coupled with various training and orientation seminars on T&CM modalities such as basic and advance Acupuncture, Tuina Massage, Ear Acupuncture, proper use of medicinal plants and other related topics to health care providers and the community.

Standards, guidelines and codes of ethical practice appropriate for the practice of traditional and alternative health care were also developed in order to provide safe, effective and affordable T&CM services to the Filipinos by certified practitioners and accredited T&CM facilities.

As we continue to harness an effective and efficient service, PITAHC was among the first to comply with the President's directive to streamline its services, in consonance with RA 11032 otherwise known as Ease of Doing Business and Efficient Government Service Delivery Act (EODB-EGSD). Likewise, PITAHC's pursuit for excellent, professional and compassionate service to its clients as an ISO 9001:2015 certified government institution bore fruit when the Institute was recognized by the Government Quality Management Committee (GQMC) in October 24, 2019 at the Philippine International Convention Center, Pasay City.

RESEARCHES ADOPTED BY THE INDUSTRY

PITAHC in collaboration with the University of the Philippines – Manila, completed the Technological Document Preparation of Tsaang Gubat (*Carmona retusa* (*Vahl*) *Masam*) syrup as anti-colic (pediatric formulation). Through a technology presentation which was attended by pharmaceutical companies held at PITAHC office last December 4, 2019, two (2) pharmaceutical companies expressed interest to adopt the said technology.

PITAHC would like to showcase different T&CM modalities, thus the ideas of renting the ground floor space for the establishment of different T&CM clinics. The ground floor of the building consists of the following clinics: Safe Haven Chiropractic Clinic, Hilot (Iraynon-Bukidnon) Clinic, Philippine Academy of Acupuncture Inc. (PAAI) Acupuncture

Clinic, Ayurveda and Electro-Therapy Center, and the Richter Alternative Medical Center and Richter Organic Café.

HILOT (IRAYNON-BUKIDNON) CLINIC

Philippine traditional healing hilot, is an ancient Filipino art of healing, it is a secret art used by our ancestors even before the Spaniards colonization. Because of its concealment, it is very unusual that the hilot expert impart their knowledge to the community. It is a family knowledge passed down from generation to generation.

PHILIPPINE ACADEMY OF ACUPUNCTURE INC. (PAAI) ACUPUNCTURE CLINIC

The PAAI is an organization of medical and nonmedical practitioners of acupuncture, duly recognized by the PITAHC. PAAI promotes high standards of ethical and professional practice in the delivery of complementary, alternative and traditional health care, particularly acupuncture, based on the fundamental principles of primacy of patient's welfare, patient's autonomy and social justice, as well as set of definitive professional responsibilities.

SAFE HAVEN CHIROPRACTIC CLINIC

Chiropractic Medicine is a form of alternative medicine typically involved with the diagnosis and treatment of mechanical disorders of the musculoskeletal system, especially the spine. It commonly uses hands-on spinal manipulation and other alternative treatments.

Its philosophy being that proper alignment of the body's musculoskeletal structure, particularly the spine, will allow the body to heal itself without surgery or medication. Manipulation is used to bring back the mobility to joints restricted by tissue injury caused by a traumatic event, such as falling, or repetitive stress, such as sitting without proper back support.

Safe Haven Chiropractic clinic offers chiropractic services and it is done by its owner Skip Pizarro, DC a chiropractic doctor and a PITAHC certified chiropractic practitioner.

AYURVEDA

Ayurvedic medicine or "Ayurveda" is one of the world's oldest holistic healing systems. It was developed more than 3,000 years ago in India. It's grounded on the belief that health and wellness depend on a delicate balance between the mind, body and spirit. Its main goal is to promote good health, not fight disease. But treatments may be geared toward specific health problems.

While Electro-therapy uses electrical energy as a medical treatment. In western medicine, the word electrotherapy can pertain to a variety of treatments. The term has also been related to the use of electric current to speed wound healing. Moreover, the term "electrotherapy" or "electromagnetic therapy" has also been applied to a range of alternative medical devices and treatments.

The Ayurveda and Electro-Therapy clinic at the ground floor PITAHC building offers Ayurveda and electro-therapy service at an affordable price.

RICHTER ALTERNATIVE MEDICAL CENTER AND RICHTER ORGANIC CAFÉ

Naturopathic medicine is a system that uses natural remedies to help the body to foster self-healing. It holds many therapies, including herbs, massage, acupuncture, exercise and nutritional counseling.

The Richter Alternative Medical Center offers different services, such as Hydrotherapy colonics, live blood analysis, complete detox therapy, juicing therapy, biozapper therapy, to name a few.

Aside from the clinic, they also have an organic café which is also located at the ground floor of the PITAHC building. The café offers a health alternative to fast foods and other foods available nearby PITAHC. They have a salad bar and a healthy combo meal which is a great choice for those who want to eat healthy foods.

PARTICIPATES IN DOH'S 121ST ANNIVERSARY

THE Department of Health (DOH) celebrated its 121st anniversary on June 23 with the theme "ToDOH Arangkada Tungo sa Universal Health Care: Alamin mo, kasama ka rito". It is a weeklong celebration emphasizing the significance of employees with respect to its effort in the implementation of the UHC law.

Since June 23 falls on Sunday, the DOH celebrated its anniversary from June 17 to 21.

At the DOH flag-raising ceremony, Philippine Institute of Traditional and Alternative Health Care (Pitahe) director general Dr. Annabelle Pabiona-de Guzman introduced the series of activities, including traditional- and complementary-medicine practices,

namely, chiropractic medicine, acupuncture and hilot.

Chiropractic medicine for wellness

DOH officials and employees lined up for free chiropractic treatments.

The treatment was headed by Dr. Martin Camara, a chiropractic doctor and the current president of the Association of Professional Chiropractors of the Philippines. He is also the current board chairman of the Pitahc and, at the same time, the National Certification Committee for Chiropractic Medicine.

Together with his team consisting of a chiropractic doctor, medical doctor, nurse, physical therapist and chiropractic assistants, they treated DOH employees of their back pains, neck pains and spine misalignment.

In addition to Dr. Camara's group, Rob Walcher and his group, together with his wife Patricia Javier, likewise, perform free chiropractic treatment to DOH officials and employees.

Acupuncture and 'hilot' for pain management

ACUPUNCTURE is a traditional Chinese medicine originated thousand of years ago. This healing modality is based on the principle of a blockage or disturbance in the flow of the body's life energy, or "Qi", which can cause health problems.

The Philippine traditional healing (hilot), on the other hand, is an ancient Filipino art of healing used by our ancestors even before the Spanish colonization. It is a popular method of healing that is commonly used in the province. It uses traditional Filipino herbal medicine and oils as part of the practice.

This form of healing was the only form of medical care in early times. Even today in the province, specially in far-flung areas, hilot is still used by many people.

On the fourth day of the DOH anniversary the Pitahc showcased acupuncture medicine and the traditional Filipino healing (hilot). DOH employees got a free acupuncture treatment and hilot for pain healing.


Training on

Acupuncture

In support of the goal of PITAHC to integrate T & CM in the national health care delivery system, training on acupuncture (basic and advance), cupping/ventosa and moxibustion, the modalities which are recognized by the World Health Organization (WHO) were conducted in the following:

A total of **ninety nine (99) medical** and allied professionals were trained in basic acupuncture and **seventy two (72)** were trained in advance acupuncture.





T&CM

Advocacies

The book Patnubay sa Pagganit ng Halamang Gamot aims to foster Philippine traditional medicine through the scientific use of herbal medicines and other indigenous or traditional methods of treatment that is based on the rich culture of the Filipino people. More importantly, the book is used as a guide and reference in the conduct of lectures and demonstrations to increase awareness on the proper use and preparation of medicinal plants for primary health care. Throughout the year, the Institute has been reaching out through advocacy campaigns especially the indigenous peoples in the different barangays in the geographically isolated disaster prone areas nationwide.

Standards and Accreditation



FORMULATION OF COMPETENCY STANDARDS FOR AYURVEDA

The competency standards defines the minimum required stock of knowledge, skills, attitude for traditional health care professionals and workers in the area of Ayurveda. It addition, it defines the required standards for those who will teach the practice in the future. Likewise, said standards also defines the proper roles and orientation needed for practice relevant and appropriate to Philippine setting. It shall also be the basis for creating the certification and accreditation guidelines for the practice as well as the training syllabus and course curriculum of Ayurveda. A public consultation on the said standards was conducted last December 12, 2019.





Development of **Policy Framework and Guidelines for Regulations** of T & CM Modalities

This involves the formulation and development of policy systems support on the regulation of T & CM practices and facilities to PITAHC towards becoming the regulatory agency for T & CM in the Philippines.

Certification/ Accreditation of T&CM Practitioners, Clinics, Training Center and Organization

Continuous evaluation for certification/accreditation of T & CM practitioners, clinics, training center and organizations were carried out throughout the year. A total of **one hundred five** (105) acupuncturists were certified, and **five** (5) acupuncture clinics, and **three** (3) training centers were accredited.

As of December 2019, there are now a total of **one thousand eighty five (1,085)** certified acupuncturists, forty (40) clinics, thirteen (13) training centers and nine (9) organizations accredited. In the same year, a total of twenty (20) chiropractors were certified. As of December 2019, there are now a total of sixty seven (67) certified chiropractors. Likewise, a total of one hundred eight (108) naturopaths were certified and four (4) naturopathy clinics were accredited. As of December 2019, there are now a total of one hundred twenty three (123) certified naturopaths, five (5) clinics and three (3) training centers accredited. Moreover, thirteen (13) hilot practitioners were certified during the year.



LGU Orientations on Certification and Accreditation

PITAHC conducted five (5) LGU orientation on certification and accreditation requirements on T & CM modalities in Regions I-Ilocos Norte, IV-B-Puerto Princesa, V-Legaspi City, VI-Bacolod City, and IX-Zamboanga City. This was participated in by City Health Officers (CHOs), Municipal Health Officers (MHOs) and Business Permit Licensing Officers (BPLOs).



Monitoring of T & CM Practitioners and Clinics

To ensure compliance to set standards and guidelines in the practice of different T & CM modalities, monitoring visits were carried out to fourteen (14) certified T & CM practitioners and four (4) accredited clinics and two (2) training centers in Bacolod City and Surigao City. Likewise, pre-monitoring visits were conducted to four (4) naturopathy clinics in Laguna and Metro Manila for their qualification for clinic accreditation.

Amendment of IRR of RA 8423



In 2018, PITAHC commissioned a team of consultants, Olive Firme and Associates Law Firm, to review and prepare proposed amendments to the current IRR of TAMA Law (8423). Series of group discussions and public consultations were conducted and participated by different T & CM practitioners, advocates, academe, stakeholders, private entities and concerned government agencies whose opinions and comments were considered accordingly. Such amendment will give PITAHC its regulatory power in the practice of T & CM modalities that shall ensure the safety and protection of the general public from unqualified T & CM practitioners. The revised IRR was approved by the PITAHC Board of Trustees last November 14, 2019 and was published in a newspaper of general circulation, the Philippine Star on November 25, 2019. It is also currently available at PITAHC website.



Ease of Doing Business in the Institute

In consonance with Republic Act No. 11032 otherwise known as Ease of Doing Business and Efficient Government Service Delivery Act of 2018 Implementing (EODB-EGSD) Regulations (IRR), PITAHC was one of the first government institutions to streamline its external and internal services. Processing of applications and renewal for certification and accreditation of T & CM practitioners and facilities was hastened; evaluation process of research proposals for possible funding was also improved. PITAHC commits to continue improve its services as it transitions towards automation of its various services and processes in the next three years through the "one-stop shop system".

Herbal Processing Plants

Cagayan Valley Herbal Processing Plant (CVHPP)
Cagayan Valley Herbal Processing Plant (CVHPP) and Davao Herbal Processing Plant (DHPP)

Cagayan Valley Herbal Processing Plant (CVHPP) and Davao Herbal Processing Plant (DHPP) completed standardized formulations for the eight (8) variants of herbal soap such as Akapulko, Bayabas, Kamias, Papaya, Labanos, Carrot, Calamansi, and Cucumber. The two HPPs were granted their License to Operate (LTO) as Cosmetic Manufacturer by the Food and Drug Administration last October 1, 2019 and September 2, 2019, respectively. The CVHPP has completed ninety percent (90%) product development of akapulko ointment, as anti-fungal. Therapeutic claim (micro assay and bioassay) based on different concentration is for finalization and is expected to be completed by 2020.





Davao Herbal Processing Plant (DHPP)

DHPP carried out technical assistance to students and researchers in their researches on

The DHPP is currently the main source of experimental animals being used by researchers and students in the region. It also served as a venue for Manufacturing Internship of Pharmacy students from Lourdes College, Cagayan de Oro City, Liceo de Cagayan, Cagayan de Oro City, University of the Immaculate Concepcion and Davao Doctors College, Davao City.



BUDGET DISTRIBUTION 2019


PITAHC Budget by Major Final Output, 2019
