- 4. Based on the average PPAS, the eligible delivery units shall be forced ranked according to the following categories.

- 5. As may be agreed upon by the Management Committee (ManCom), the Performance Management Team and the Delivery Units, aside from the Institute's performance targets under the Performance Informed Budget (PIB) GAA of 2020, additional targets maybe considered and accomplishments of the said targets shall be added in the rating of delivery units.
- 6. Subtraction from the Average PPAS score shall be as follows:
 - = 10% for every delivery unit with less than 100% unutilized budget
 - = 1% for every incorrect item in the submission of report
- 7. In case of ties among the delivery units, the Performance Management Team shall rank the units with additional accomplishments other than those identified in their performance targets.
- 8. For appeals on the PBB eligibility and ranking, a letter of request for reconsideration shall be submitted to the Head, PMT through the PBB Secretariat at pitahc@gmail.com within five (5) working days from the release of the PBB rating and ranking. Appeals sent beyond the said timeframe shall no longer be considered.
