PITAHC further reserves the right to reject all proposals, or declare a failure of small value procurement, or not award the contract, and makes no assurance that the contract shall be entered into as a result of this invitation without thereby incurring any liability to the affected bidder or bidders in accordance with R.A. No. 9184 and its Implementing Rules and Regulations.

#### **TERMS AND CONDITIONS**

- 1. Bidders shall provide the **correct and accurate information** required in this form.
- 2. Delivery Schedule: **LOT 1:** Sixty (60) Days from receipt of the final approved sample from PITAHC; **LOT 2:** Sixty (60) Days from receipt of the final approved sample from PITAHC (Items 1-3); Sixty (60) Days from receipt of the Purchase Order (Item 4)
- 3. Delivery Site: PITAHC Central Office
- Payment Term: LOT 1: Sixty (60) Days from the date of inspection and acceptance of complete items; LOT 2: Sixty (60) Days from the date of inspection and acceptance of complete items
- 5. Price proposal must be valid for a period of **thirty (30)** calendar days from the date of submission.
- 6. Price proposal to be denominated in **Philippine Peso (PhP)**, include all taxes and duties and/or levies payable.
- 7. Proposals exceeding the ABC PER LOT shall be automatically rejected.
- 8. As part of the submission aside from Item No. 5 of the RFP and the Price Proposal Form, bidder shall submit a Certificate of Satisfactory Completion/Performance for those who have previous contracts with PITAHC, if applicable.
- 9. The **award of contract** shall be made to the single or lowest calculated and responsive proposal PER LOT, which complied with the minimum technical specifications and other terms and conditions stated herein.
- 10. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the bidder or any of his/her duly authorized representative/s.
- 11. Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. PITAHC shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open.
