The Bidder must have completed a single contract that is similar to this Project, equivalent to at least twenty-five percent (25%) of the ABC.	 The SLCC requirement has been revised. 5.3 Pursuant to Section 23.4.1.3 of the 2016 revise IRR of RA No. 9184, the Bidder shall be given the following options for their SLCC similar to the Project the value of which, adjusted to currer prices using the PSA's CPI, must be at least equivalent to: a. a single contract that is similar to the Project, equivalent to at least twenty-five percent (25%) of the ABC;
	b. at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least 25% of the ABC as required above; and the largest of these similar contracts must be equivalent to at least half of the 25% of the ABC as required above. For this purpose, the similar contracts mentione above must have been completed within the period specified in the Invitation to Bid.
