OVERVIEW

The Philippine Institute of Traditional and Alternative Health Care (PITAHC) is a government owned and controlled corporation created by virtue of Republic Act 8423, otherwise known as Traditional and Alternative Medicine Act (TAMA) of 1997 is mandated to promote and develop the use of traditional and alternative health-care in the country. Its main objective is to improve the quality and delivery of healthcare services to Filipinos by integrating traditional and alternative healthcare into the national healthcare delivery system.

In line with this, PITAHC envisions itself as an agency that will improve "People's health through traditional and alternative health care."

Its mission is "to lead in the research and development, promotion and advocacy, and development of standards on traditional and complementary medicine (T&CM); and we ensure its accessibility, availability, sustainability and integration into the national health care. system."

PITAHC is currently headed by Director-General Ma. Teresa Co-Iñigo, MD under the direction of a Board of Trustees composed of representatives from different government agencies namely: Department of Science and Technology (DOST); Department of Environment and Natural Resources (DENR); Department of Agriculture (DA); Commission on Higher Education (CHED); and representatives from the industries/sectors namely: a physician engaged in the practice of Traditional and Complementary Medicine (T&CM); a member from a duly recognized academe engaged in T&CM research; a T&CM practitioner who is not a physician; a western medical practitioner preferably from the Philippine Medical Association; one member from the natural food industry and one member from environmental sector. The board is chaired by the Secretary of Health.

Likewise, the 4th Regional Hilot Congress was held in Candelaria, Quezon wherein various Hilot practitioners from several areas of CaLaBaRZon converged to promote Hilot as the only traditional medicine in the Philippines and discuss the process and requirements on how to get certified/recognized as a Hilot practitioner.

In November 13-14, 2024, the 16th TCIM Conference was held and was attended by practitioners of TCIM modalities like Acupuncture, Naturopathy, Hilot, Chiropractic, Homeopathy/Homotoxicology and presented the latest news and updates in TCIM practice as well as showcased several TCIM products. To culminate the year's activities, the 1st PITAHC Academia Research Summit (PARS) was held in Ardenhills Suites, Quezon City last December 6, 2024. The activity gathered various researchers and students from the academe to encourage them to submit research proposals for possible funding by the Institute.

PITAHC will not be able to achieve all of these without the overwhelming support of its stakeholders and oversight agencies like the Department of Health, Department of Budget and Management, Commission on Audit and Civil Service Commission, for these, we are forever grateful.

- 3. Number of research projects completed/developed.


Researches adopted by the industry







Research projects completed/developed

- Completed projects shall be defined as those projects that have undergone and satisfactorily fulfilled all stages of the prescribed procedural framework, including but not limited to the submission of required documentation, evaluation by technical reviewers, and formal approval by the Director General or from the Board of Trustees. For the purposes of reporting and compliance, a project shall only be deemed 'completed' upon the issuance of a formal written endorsement or approval by the designated technical reviewers attesting to its adherence to established technical, financial, and operational standards.
- Developed projects shall refer to undertakings initiated by the Philippine Institute of Traditional and Alternative Health Care (PITAHC), which have undergone the requisite review and evaluation process. These projects shall be deemed as such only upon the formal approval of the Director General, evidenced by the issuance of duly executed and finalized Terms of Reference (TOR), Terms and Conditions (T&C), and any related supporting documentation. Such approval signifies that the project is aligned with PITAHC's mandates, objectives, and operational guidelines, ensuring compliance with applicable rules.

3. Other R&DD Accomplishments

PITAHC Academia Research Summit

PITAHC through its Research and Development Division (RND), successfully held the PITAHC Academia Research Summit Meeting on December 6, 2024, at Ardenhills Suites Hotel, Quezon City. This event marked the first meeting of the PITAHC Academia Research Summit (PARS), led by PITAHC Director General Dr. Ma. Teresa C. Iñigo. In her welcome address, Dr. Iñigo underscored the critical role of high-impact research in advancing Traditional, Complementary, and Integrative Medicine (TCIM). She encouraged researchers to focus on TCIM modalities and natural products with marketready potential, emphasizing PITAHC's commitment to integrating TCIM into the national healthcare system and enhancing its accessibility for all Filipinos.



Representatives from 12 universities and schools across Metro Manila and Greater Manila joined the event, fostering meaningful collaborations aimed at advancing TCIM research and innovation. We sincerely thank all participants and partner institutions for their valuable contributions to this initiative. Together, we are bridging tradition and innovation to transform healthcare.



Establishment of PITAHC Central Office Laboratory

The PITAHC Central Office Laboratory is continually improving its processes to align with the organization's dedication to quality, safety, and adherence to national regulatory standards.

Significant Accomplishments in Fiscal Year 2024

1. Application for the PRC Certificate of Authority to Operate

In alignment with PITAHC's strategic objective to achieve comprehensive regulatory compliance, the Central Office Laboratory submitted its application for the PRC Certificate of Authority to Operate in early 2024. This application corresponds with the laboratory's objective to adhere to industry standards for quality assessment of traditional and complementary medicine items.

2. Preliminary Inspection and Observations of the PRC

In July 2024, the PRC performed a preliminary evaluation of the PITAHC Central Office Laboratory as a component of the certification procedure. The evaluation concentrated on the laboratory's architecture, apparatus, staff, and operational protocols. According to the findings, the PRC recognized multiple areas for enhancement, which PITAHC proactively sought to rectify.

3. Adherence to PRC Regulations

In accordance with the PRC's recommendations, PITAHC commenced the implementation of the following compliance actions to fulfill the Commission's requirements:


a. **Preparation of the PITAHC CO Laboratory Safety Manual**: The laboratory promptly initiated the creation of a detailed Safety Manual, encompassing laboratory methods, safety standards, and emergency procedures to safeguard staff and adhere to industry safety laws.

b. **Development of Analytical Procedure Manual:** PITAHC developed an Analytical Procedure Manual to standardize and codify testing operations, detailing the methodologies and standards for conducting precise and dependable tests on herbal and traditional medicine items.

c. **PITAHC instituted a Hazardous Waste Management policy** to guarantee the appropriate disposal of chemical and biological waste in accordance with environmental safety regulations.

d. **PITAHC nominated a qualified CHEMIST III** as Head of the Laboratory in response to the PRC's proposal to formalize the laboratory's leadership structure, guaranteeing appropriate oversight and compliance with regulatory standards.



Hilot Congress 2024

The Standards and Accreditation Division has successfully conducted the 4th Hilot Congress on September 19-20, 2024, at the Dalampasigan Beach Resort in Sariaya, Quezon, with the main objective of preserving the traditional healing practices of the country.

PITAHC is hoping that through the Hilot Congress, more Hilot practitioners from all over the Philippines will connect with PITAHC to secure recognition, certification and accreditation of Hilot facilities. This further aimed at ensuring that the traditional healing practices of the country stay alive, monitored by PITAHC and with the safety of practitioners and clients being guaranteed.

The activity was conducted in coordination with the DOH CaLaBaRZon Center for Health Development and the Provincial Health Office of Quezon Province.

The main objective of the Congress is to promote Hilot as the only traditional medicine in the Philippines, the process and requirements on how to get certified/recognized as a Hilot practitioner. It was participated in by 50 hilot participants coming from different municipalities in the provinces of Quezon (Dolores, Tayabas, Sariaya, Candelaria) and Laguna (Pagsanjan and Majayjay).









TCIM Orientation

To enhance understanding of the Division's Certification and Accreditation (C&A) processes, two TCIM Orientations were conducted in 2024, held on March 22nd at the PITAHC AVR, and on June 13th at the PITAHC Mini Theater and on April 18, virtually.

These sessions were designed to equip both current practitioners and prospective applicants with the knowledge and tools necessary for successful C&A applications. Participants received guidance on completing application forms accurately and efficiently, in-depth reviews of current requirements and any recent updates, and strategies for ensuring applications meet all criteria and maximize the likelihood of approval. By providing this valuable information, PITAHC strives to streamline the C&A process, improve application success rates, and ultimately enhance the quality of healthcare services within the Division.

This was attended by 150+ practitioners from all PITAHC-recognized modalities.



Monitoring and Inspection

To ensure the quality of services being provided by TCIM modalities by its certified practitioners and the accredited facilities, PITAHC through its Standards and Accreditation Division regularly conducts monitoring of certified practitioners and accredited facilities. Facilities applying for accreditation are also inspected to ensure that these facilities adhere to the approved standards.



ESTABLISHMENT OF TCIM CENTERS in DOH Centers for Health Development, DOH-Hospitals, and LGU Hospitals

The Philippine Institute of Traditional and Alternative Health Care (PITAHC) through the Social Advocacy & Training Division, in collaboration with the Department of Health (DOH) Centers for Health Development (CHD), DOH hospitals, Treatment and Rehabilitation Centers (TRC), Local Government Unit (LGU) hospitals, and Rural Health Units (RHUs), supports the establishment of TCIM Centers within their facilities. This initiative aims to provide safe, and effective Traditional, Complementary, and Integrative Medicine (TCIM) services while promoting its integration into the national healthcare delivery system, contributing to universal health coverage

To accelerate the development of TCIM nationwide, PITAHC encourages all TCIM Centers to formalize their partnership through a Memorandum of Agreement (MOA). These centers offer the following services: acupuncture, anthroposophic medicine, ayurveda, chiropractic, hilot, homeopathy & homotoxicology, naturopathy, osteopathy, traditional Chinese medicine, tuina massage, and other TCIM practices. By leveraging the expertise of these organizations, TCIM Centers deliver high-quality healthcare services and enhance the integration of Traditional and Alternative Health Care (TAHC) into the broader healthcare system.

As of December 2024, PITAHC's Social Advocacy and Training Division (SATD) has signed Memorandums of Agreement (MOAs) with seven (7) hospitals and facilities nationwide, bringing the total number to 27 since 2021.

PITAHC Hospital Congress

The Philippine Institute of Traditional and Alternative Health Care (PITAHC), through the Social Advocacy & Training Division, successfully conducted the 6th Hospital TCIM Congress on August 13-14, 2024, at the Citystate Tower Hotel in Manila. With the theme "Integrative Approaches to Healthcare: Ensuring Quality, Safety, and Efficacy through TCIM," the event brought together 93 participants from various Department of Health (DOH) hospitals.

The congress aimed to review and discuss strategic health policies and operational issues related to raising the profile of Traditional and Complementary Medicine (TCIM) in the Philippines. It also sought to establish hospital models for integrating TCIM services into existing service delivery networks of DOH-retained and local government unit (LGU) hospitals. Furthermore, the event explored the challenges and issues faced by hospitals in establishing Traditional and Alternative Health Care (TAHC) Centers within DOH-retained facilities. This initiative reflects PITAHC's commitment to advancing TCIM as a vital component of the national healthcare system.

The Philippine Institute of Traditional and Alternative Health Care (PITAHC), through its Social Advocacy & Training Division, successfully held the 16th Traditional and Alternative Health Care (TAHC) Congress on November 13-14, 2024, at the Citystate Tower Hotel in Ermita, Manila. The event, themed "Traditional Complementary and Integrative Medicine in Universal Health Care: Addressing Challenges and Seizing Opportunities for Holistic Health," highlighted the integration of TCIM within the UHC framework.

The congress drew significant participation, with 376 attendees on the first day and 385 on the second day, representing various PITAHC-approved practices. This gathering served as a platform to promote dialogue, collaboration, and innovation in advancing holistic health approaches in the country.





PITAHC Seal of Excellence

The PITAHC Seal of Excellence is a search for outstanding champions of Traditional and Complementary Medicine (T&CM) among Local Government Units (LGUs), the Department of Health (DOH) Centers for Health Development (CHDs), and DOHretained hospitals. Developed by the Philippine Institute of Traditional and Alternative Health Care (PITAHC), this award system encourages these entities to actively implement the objectives of Republic Act 8423 (Traditional and Alternative Medicine Act) and its implementing rules and regulations, along with related programs and activities.

The PITAHC Seal of Excellence aims to promote the highest professional standards in T&CM, recognize outstanding practices and contributions by LGUs, DOH-CHDs, and DOH-retained hospitals, and uplift T&CM practices that contribute to a whole-of-society approach to healthcare. By emphasizing community-level delivery of many T&CM modalities, the initiative seeks to improve the health and well-being of Filipinos across all sectors. Furthermore, it inspires active implementation of RA 8423, along with PITAHC's programs and initiatives.

The awarding ceremony took place on June 27, 2024, at the Swiss-Belhotel Bluelane in Manila, with 136 participants, including representatives from the PITAHC Central Office, Herbal Processing Plants, partners, stakeholders, and awardees. A total of 33 awards were presented, consisting of 14 Gold, 6 Silver, 4 Bronze, and 9 Plaques of Appreciation.



ACUPUNCTURE TRAINING (BASIC & ADVANCED)

In support of PITAHC's goal to integrate Traditional and Complementary Medicine (T&CM) into the national healthcare delivery system, the Social Advocacy & Training Division (SATD) conducts training programs on PITAHC-approved and recognized practices, including acupuncture. These programs aim to promote the use of Traditional, Complementary, and Integrative Medicine (TCIM) practices, products, and services as complementary and integrative approaches to managing common health conditions. They also strive to equip healthcare professionals with TCIM skills essential for maintaining population health.

The acupuncture training program consists of both basic and advanced courses and provides continuous education for medical and allied health workers, focusing on traditional and alternative healthcare practices. It seeks to develop a substantial pool of healthcare professionals skilled in acupuncture to support the integration of TCIM into hospitals and foster the establishment of a network of acupuncture practitioners among doctors and allied health workers.

In 2024, PITAHC conducted 18 training sessions, comprising seven basic and eleven advanced courses, with a total of 401 participants. This initiative reflects PITAHC's dedication to enhancing the expertise of healthcare professionals in T&CM and advancing its integration into the national healthcare system.



COMMUNITY-BASED TRAINING

PITAHC conducts community-based training programs in response to requests from local government units (LGUs), Centers for Health Development (CHDs), DOH hospitals, and other stakeholders. These programs aim to equip barangay health workers and community members with practical knowledge and information on Traditional Complementary and Integrative Medicine (TCIM) practices, products and services to address common ailments effectively.

The training promotes the proper use and preparation of traditional medicine through orientation and hands-on instruction in various TCIM practices. Additionally, it seeks to empower communities with TCIM knowledge for preventing and treating common illnesses, managing existing health conditions, and maintaining overall well-being. The training also includes orientation on the TAMA Law, education on the ten DOHapproved medicinal plants (Halamang Gamot), acupressure techniques for common illnesses, and the preparation of herbal medicines.

In 2024, PITAHC successfully conducted 199 community-based training sessions, reaching a total of 6,419 participants. This initiative highlights PITAHC's commitment to promoting accessible and sustainable healthcare solutions at the grassroots level.





HERBAL PROCESSING PLANTS (HPPs)

PITAHC has three (3) Herbal Processing Plants (HPPs) located in Tuguegarao, Tacloban, and Davao Cities which are tasked to produce herbal products as well as develop/formulate new TCIM products for FDA Registration/Notification. They also process raw materials that are being used for the production of Lagundi and Sambong tablets and production of herbal soaps.

These HPPs are also essential in the implementation and roll-out of the different activities of the three Major Final Outputs of PITAHC such as Research and Development, Technical Advisory and Advocacy Services, and Regulation of Traditional and Alternative Practice.

Further, these HPPs provide vital services for Pharmacy students to complete their academic requirements such as internship programs for herbal products development. They also provide bioassay services and breed laboratory animals (mice) for laboratory use.

Production of Quality and Affordable Herbal Medicines and Products:

The Cagayan Valley Herbal Processing Plant (CVHPP) was able to achieve its target for herbal soap production for FY 2024, while Davao Herbal Processing Plant (DHPP) was able to produce 16, 735 bars.





Engagement with International Partners and Stakeholders





PITAHC Client Satisfaction in Service Provision


Aligned with PITAHC's commitment to its Quality Management System (QMS), the client or customer satisfaction measurement is being conducted to measure and evaluate the degree of client's perception to which their needs and expectations have been fulfilled by the Institute.

For FY 2024, a total of four hundred fifty (450) respondents were served by PITAHC staff from January to December 2024 and have submitted accomplished PITAHC CSS forms. PITAHC received an overall impression from their respondents (clients served) with an average score of 4.88 with an adjectival rating of "Very Satisfactory".


Based on the data collected in 2024, 285 (63%) were female while 165 (37%) male clients were served by PITAHC.



For the client group, two thirds or 66% (297) of the respondents were Citizens or individuals, 26% (115) were from the Government and 8% (38) were from the business group.



The most number of respondents for this year's survey was from the Business Development Department with 116 respondents out of the 450 total respondents (26%) from January to December 2024. It was then followed by seventeen (17%) or 76 of the respondents having their services availed through the Standards and Accreditation Division. The third most number of clients served with accomplished CSS forms was from the Administrative Division with 52 respondents. The Finance Division (1), Office of the Director General (5) and Research and Development Division (9) had the least number of respondents.



The respondents perceived that PITAHC exceeded their expectations in terms of Responsiveness, Communication, and Integrity.

PITAHC Staff as Regulatory Impact Assessment Champions

PITAHC actively supports Anti-Red Tape Authority's efforts to implement a national policy against red tape and to promote ease of doing business, in relation to these efforts, PITAHC staff were among the participants in the series of training on Regulatory Impact Assessment (RIA). Additionally, a significant milestone was the implementation of the PITAHC Integrated Management Information System (PIMS) and PITAHC Accreditation and Certification Electronic Service System (PACESS), designed to streamline operations, enhance data management, and improve operational workflows and service delivery, with continuous patches and updates to ensure adaptability to the organization's required standards.

HUMAN RESOURCE DEVELOPMENT


