CONTRACT AGREEMENT

THIS AGREEMENT for the INTERNET SERVICES made the ____ day of ____ 2025 between the PHILIPPINE INSTITUTE OF TRADITIONAL AND ALTERNATIVE HEALTH CARE (PITAHC) of the Philippines, hereinafter called "the Entity" of the one part and CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC (CONVERGE) with office address at E. Rodriguez Jr., Avenue, Barangay Ugong, Pasig City, Philippines, hereinafter called "the Service Provider" of the other part;

Herein referred to as "the Parties".

WHEREAS, the Parties entered into a contract dated 7 December 2023 for Internet Service ("Original Contract") in accordance with the provisions under Republic Act 9184 (Government Procurement Reform Act) and its implementing rules (collectively, "Procurement Laws"). The Original Contract expired on 6 December 2025 but was subsequently extended for three (3) months or until 6 March 2025.

WHEREAS, consistent with applicable provisions of Procurement Laws (i.e., Appendix 21, Updated 2016 Implementing Rules and Regulations) PITAHC conducted a Cost Benefit Analysis and thereafter determined that the renewal of the Original Contract with CONVERGE is most advantageous to PITAHC, as shown in the Request for the Renewal of Internet Service for One (1) year with CONVERGE with Cost Benefit Analysis, attached herewith as Annex "A" and "B", respectively.

WHEREAS, PITAHC desires to renew the Original Contract under the same terms and conditions for a period of One (1) Year from 7 March 2025 (the "Renewed Term") and CONVERGE is willing to continue providing the service within the Renewed Term in the sum of Five Hundred Ten Thousand Seven Hundred Twenty Pesos (Php510,720.00.00) (hereinafter called "the Contract Price"), subject to the same terms and conditions set forth in the Renewed Term.

WHEREAS, upon recommendation of the Bids and Awards Committee (BAC), the Head of the Procuring Entity approved the renewal of the contract with CONVERGE for a total contract cost of Five Hundred Ten Thousand Seven Hundred Twenty Pesos (Php510,720.00.00)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Request for Renewal of Contract of Internet Service for One (1) with Cost-Benefit Analysis (Annex "A");
 - b. Terms and Reference with Technical Specification (Annex "B");
 - c. Performance Evaluation (Annex "C");
 - d. Certificate of PhilGeps Registration (Annex "D");
 - e. CONVERGE'S Quotation (Annex "E");
 - f. Notice of Renewal and the Bidders conforme thereto (Annex "F");

- g. Performance Security (Annex "G"); and
- h. Other contract document that may be required by existing laws and/or the PITAHC in the PBDs. The Service Provider agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration of the payments to be made by PITAHC to CONVERGE, the latter hereby covenants with PITAHC to provide the services and to remedy defects, if any, in conformity with the provisions of this Agreement.
- 4. Pursuant to the terms and reference, the PITAHC hereby covenants to pay CONVERGE based on the actual use per month as stated in the monthly billing to be issued by CONVERGE. CONVERGE shall submit a monthly billing statement, access/usage and traffic report or MRTG for the particular billing period as a condition of payment and other documents as may be required by the PITAHC.
- 5. This Agreement shall be for a period of one (1) year from 7 March 2025 to 6 March 2026, which may be renewed subject to pertinent laws, rules, and regulations, as well as to the favorable assessment or evaluation of CONVERGE's performance, but in no case shall the total contract renewal exceed two years.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
