**DECLARE RESPONSIVENESS AND RECOMMEND TO AWARD THE
CONTRACT FOR THE PROCUREMENT OF SECURITY SERVICES FOR
THE TACLOBAN HERBAL PHARMACEUTICAL PROCESSING AND
MANUFACTURING PLANT WITH REFERENCE NO. RFQ CO-25-
006SVP**

WHEREAS, the Tacloban Herbal Pharmaceutical Processing and Manufacturing Plant (THPPMP), as the End-User-Unit (EUU), requested the **PROCUREMENT OF SECURITY SERVICES FOR THE TACLOBAN HERBAL PHARMACEUTICAL PROCESSING AND MANUFACTURING PLANT** with a total Approved Budget for the Contract (ABC) of **EIGHT HUNDRED EIGHTY THOUSAND FOUR HUNDRED EIGHTY-FOUR PESOS AND FIFTY CENTAVOS (PHP880,484.50)**, inclusive of all applicable taxes and other charges;

WHEREAS, on 24 March 2025, the Bids and Awards Committee (BAC) Secretariat certified its inclusion in the 2025 Annual Procurement Plan (APP);

WHEREAS, on 26 March 2025, the Finance Division certified that funds are available for the procurement of the project;

WHEREAS, on 07 April 2025, the BAC Secretariat received the approved Purchase Request No. THPP-25-03-039 from the EUU;

WHEREAS, on 08 April 2025, the BAC Secretariat drafted the Request for Quotation (RFQ) for the project and sent it to the BAC for further review, comments, and approval;

WHEREAS, on 08 April 2025, receiving no objections after further review by the BAC and EUU, the BAC Secretariat sent the RFQ to the prospective bidders. In accordance with Annex "H" V(D)(8)(b.ii) of the Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), the BAC shall prepare and send the RFQs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, on 09 April 2025, the BAC Secretariat sent the RFQ to the prospective bidders identified by the EUU, namely, **SUPERB SECURITY AND INVESTIGATION AGENCY, INC., VISION SECURITY SERVICES INC., GERCONI SECURITY AGENCY, and FLAGSS SECURITY AGENCY**;

WHEREAS, the two (2) bidders, **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** (*April 11, 2025, 10:00 AM*), and **VISION SECURITY SERVICES INC.** (*April 12, 2025, 12:41 AM*), submitted their quotations through electronic mail and manual submission within the prescribed deadline of submission, which was on 14 April 2025, 12:00 NN;

WHEREAS, after the deadline of submission and receipt of quotations, the BAC Secretariat routed the submitted quotations to Technical Working Group (TWG) for evaluation, eligibility, and verification, and to ascertain the documents requirements;

WHEREAS, on 23 April 2025, the TWG submitted its Evaluation Reports on the Legal/Eligibility, Technical and Financial Requirements of the project, and **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.**, and **VISION SECURITY SERVICES INC.** were found to be **COMPLIANT** to all the eligibility, technical and financial requirements of the project. (*Please see Technical and Financial Evaluation Report of the TWG*);

WHEREAS, on the same date, the BAC reviewed and confirmed the findings of the TWG. As there is no impending issue relative to the quotation of **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.**, the BAC declared it as the bidder with the **Lowest Calculated and Responsive Quotation (LCRQ)** for the above-mentioned project and proceeded to recommend the awarding of the contract.

NOW THEREFORE, in the view of the foregoing, the members of the Bids and Awards Committee, hereby **RESOLVE AS IT IS HEREBY RESOLVED**, to:

1. **Declare SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** as the bidder with the **Lowest Calculated and Responsive Quotation** for the **PROCUREMENT OF SECURITY SERVICES FOR THE TACLOBAN HERBAL PHARMACEUTICAL PROCESSING AND MANUFACTURING PLANT** with Reference No. RFQ CO-25-006SVP, and
2. **Recommend** to the Head of the Procuring Entity the awarding of contract to **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** for the **PROCUREMENT OF SECURITY SERVICES FOR THE TACLOBAN HERBAL PHARMACEUTICAL PROCESSING AND MANUFACTURING PLANT** with total contract amount of **EIGHT HUNDRED FOURTEEN THOUSAND FIVE HUNDRED SIXTY-FIVE PESOS AND SIXTEEN CENTAVOS (PHP814,565.16)**, inclusive of all applicable taxes and other charges.
